<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number and account transactions</li> <li>• Credit history and credit scores</li> <li>• Transaction history, mortgage rates and payments</li> </ul> <p>When you are <i>no longer</i> a customer, we continue to share your information as described in this notice</p>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons LendingTree, LLC ("LendingTree") chooses to share; and whether you can limit this sharing.

**Who is providing this notice?**

**What we do**

**How does LendingTree, LLC protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We use encryption in the transmittal of your sensitive personal information between your systems and ours and we use firewalls.

**How does LendingTree, LLC collect my personal information?**

We collect your personal information, for example, when you

- open an account or apply for a loan
- give us your contact information or provide your mortgage information
- apply for financing

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes –information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

**Definitions**

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliate include financial companies such as Tree.com, Inc.

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- LendingTree does not share with nonaffiliates so they can market to you.

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- LendingTree does not jointly market.

**Other important information**

Special Notice to California and Vermont Residents: We will not share any personal information about you with our affiliates to the extent prohibited by applicable state law or to the extent your prior consent to share is required by applicable state law.
